So next time you see a business or organization spending dollars to promote a positive message remember this - that they probably do care about the message they are sharing.



#### Legislative Updates – Property Insurance Claims

For those of you who still may be dealing with the effects from Hurricane Michael, there were some changes made during the 2021 legislative session to the Florida Statutes that pertain to property insurance claims. These changes could potentially impact Hurricane Michael insurance claims that are still pending. The changes to the legislation took effect July 1, 2021 and are now codified in statute. One important change deals with the time in which to bring a claim, a reopened claim, or supplemental claim.

Prior to July 1, 2021, an insurance company had to be notified of an insurance claim within three (3) years of the date of the storm. The 2021 version of section 627.70132, Florida Statutes, now provides that a claim OR a reopened claim is barred unless the insurance notified of the claim company was or reopened claim within two (2) years after the date of the storm. A "reopened claim" is defined in the statute to mean "a claim that an insurer has previously closed, but that has been reopened upon an insured's request for additional costs for loss or damage previously disclosed to the insurer."

On the other hand, the time in which a supplemental claim must be brought is three (3) years, rather than two (2). A "supplemental claim" is defined in the statute to mean "a claim for additional loss or damage from the same peril which the insurer has previously adjusted or for which costs have been incurred while completing repairs or replacement pursuant to an open claim for which timely notice was previously provided to the insurer."

-St. Joe has committed **\$36 million dollars** to the downtown area for a hotel and restaurant, prompting renewed interest from other investors.

-Since Hurricane Michael 170 brand new businesses and restaurants have started in Bay County.

- City improvements are popping up in St. Andrew, Millville, and Glenwood. More are coming!

- St. Andrews School which is on the Historical Registry has been slated to become a community space for music, art, history, farmers markets, and more.

# "I Have Full Coverage." — But Do You Really?

As you may or may not know, Florida is currently а mandatory Personal Injury Protection (PIP) state. One of only 12 in the country which require a driver carry PIP coverage to be legally on the road. Florida also requires a minimum of \$10,000.00 in property damage liability coverage to compensate for damages to another person's vehicle or property should the insured driver be found at fault. What does this mean? In a nutshell, PIP is designed to provide coverage to you or other qualifying individuals under your policy for immediate medical expenses and wage loss incurred as the result of an accident, regardless of fault. PIP is typically available in the amount of \$10,000.00 for each qualified person in one's insured vehicle. However, the requirement that a driver have PIP and be "legal" does not mean that they have the ability to compensate a party who is injured through their fault.

When discussing this issue I simply state that in Florida, and any other jurisdiction where it is "legal" to drive with minimum insurance such as a \$10,000.00 PIP Policy and \$10,000.00 in Property Damage, it is more important than ever to protect yourself by ensuring YOU have coverage when the at-fault driver may not. The PIP coverage offered under any policy of insurance is a minimum threshold and unfortunately, often it is exhausted very early on in the course of medical care related to an accident.

I receive calls on a weekly basis from people seeking representation for injuries sustained in car accidents and one of my first questions is, "...tell me about your insurance." People will often say, "I have full coverage" I have come to learn that means different things to different people in our minds as injury attorneys, "Full Coverage" means that you have protected yourself by way of purchasing Uninsured or Underinsured Motorist (UM) coverage. Unfortunately, as Florida is a PIP state, the legal minimum insurance for a driver to be on the road DOES NOT include Bodily Injury Liability coverage. We are working hard in the legislature to change that. However currently, the fact that an at-fault individual has insurance does not mean they can compensate an injured party for losses sustained in that collision.

UM coverage is available through most insurance carriers as an addition to your policy for what is usually a minimal increase in premiums. There are many variations of this coverage but simply put, it is a way for you to insure yourself and your family against the perils we face daily on the road. UM Coverage is available in "stacking" and "non-stacking" applications and the amount of coverage you are able to secure will depend on the baseline Bodily Injury policy carried on your motor vehicle. For

example, if you carry a 100/300 bodily injury liability policy, you would be able to secure up to \$100,000.00 in UM coverage if you own a single vehicle or \$200,000.00 if you own two and the coverage is "stacked." UM coverage is not available to drivers who carry PIP and Property Damage *only* policies of insurance. Further, there are limitations on the type of vehicles covered by UM policies, such as motorcycles. Our advice to our clients is always that you examine the options for UM coverage with your agent and secure that coverage in the event of an incident with either a minimally or uninsured driver. We know that insurance is confusing and that is why we are here. We will happily examine your current policy and tell you exactly what coverage you have and the potential future impact of the limits of that insurance.
